This is with reference to school application No.SS-91240-2324 dt.30/12/2022 on the subject cited above

In this connection, I am directed to inform that your application has been rejected on the following grounds.

1	The school has submitted recognition certificate issued from April 2015 to March 2017. In the compliance, school has submitted renewed certificate dated 08-05-2017 issued w.e.f. April 2017. In the renewed certificate there is no validity mentioned, also it is not clarified whether it is permanent recognition or not.
2	The school has not submitted Certificate of sanitation condition.
3	The school has submitted the memorandum of association and acknowledgement receipt in place of society registration certificate.
4	The school has filled land details in the application as 10027. However, during IC, it is found to be 9661 sq mtrs. In the compliance, school has submitted revised land certificate dated 26-01-2023 on e-stamp paper, wherein no seal / stamp available of the land authority. Further, as per both of the land certificates submitted by school "Punjab Model School Education Society" owned the land in term of sale deed which was registered on 05-08-2009, However, in the first certificate land area is mentioned as 9661 sq mtrs and in the second certificate it is mentioned as 10027.
5	There is variation in the details filled by the school, as per part – A, school has physics, chemistry and biology labs with sized of 750 sq ft. whereas as per the Part-B/ inspection report, there is no Biology lab. Chemistry and Physics labs are undersized.
6	The school does not have EPF facilities for its staff.
7	There is no composite science lab and separate reading space for staff in the library.
8	The school does not have separated toilets (for Girls /boys) on each floor with proper permanent signage, indicating the floor number as per norms of RPwD Act and board's guidelines (https://saras.cbse.gov.in/SARAS/Circulars/Circular05_2023.pdf).
9	Height of the boundary wall is appears to be less than 6 ft. As per the norms, the school should be bounded with the concrete boundary wall with minimum 6 ft of height

Further, as per clause 10.5.2 of Affiliation Bye-Laws, 2018, the fee deposited will not be refunded or adjusted irrespective of the grounds on which the application has been rejected even if the school has not been inspected.

The school may seek a review of the above decision of the Board within 15 days on SARAS portal.
